**HED 299-Special Topics: Health Disparities** 3 credit hours. This course is designed to explore health inequities and health disparities in the United States and to understand the root causes that impact them. This includes exploration of the interplay of determinants of health (e.g., housing, income, transportation, food outlets, and crime), behavioral, social, cultural, political factors impact the health of communities. This course will provide students with a foundation for understanding how history, power, privilege and structural inequality interact to produce health disparities. The course focus will also address cultural competency, cultural humility, and appropriate health education and promotion strategies needed to create healthier communities. **Mississippi University for Women. Spring 2018.** 

**HED 313-Adolescent Health** 3 credit hours. This course is designed to examine adolescent morbidity and mortality within a social context taking into account the influence of the social environment. Topics covered include the epidemiology of health problems, developmental issues, health services, and psychosocial influences on adolescent problem behaviors. Integrated into this will be the role of development and the unique period of adolescence. **Mississippi University for Women. Fall 2017. Spring 2018. Fall 2018.** 

HED 314-Principles of Epidemiology 3 credit hours. This course covers applications of epidemiologic methods and procedures to the study of the distribution and determinants of health and diseases, morbidity, injuries, disability, and mortality in populations. Epidemiologic methods for the control of conditions such as infectious unintentional injuries are discussed. Other topics include quantitative aspects of epidemiology, for example, data sources, measures of morbidity and mortality, evaluation of association and causality, and study design. *Mississippi University for Women. Fall 2017. Spring 2018. Summer 2018. Fall 2018.* 

**HED 315-Infectious Disease Epidemiology** 3 credit hours. This course presents an overview of the impact of infectious disease on public health, in this course, students will explore how a biological and molecular understanding of infectious disease can be incorporated into public health decision-making. This course will also cover basic epidemiologic methods central to the study of infectious diseases. **Mississippi University for Women. Fall 2017. Spring 2018. Fall 2018.** 

**HED 330-Stress Management** 3 credit hours. This course is designed as an introduction to the relationship that exists between stress and health. Selected methods of relaxation and stress management will be discussed, demonstrated, practiced, and analyzed. *Mississippi University for Women. Fall 2017. Spring 2018. Fall 2018.* 

HHE 273-Community and Public Health 3 credit hours. This course is an introduction to the practice of community and public health. Public health encompasses actions that society takes collectively to ensure that the conditions in which people can be healthy can occur.
